Who is responsible for your information?

Thamesmead Community Archive is commissions by Peabody Trust and Thamesmead Arts and Culture Office (TACO!), they are the data controller for the purposes of any personal data held as part of this archive.

How we use your information

Where the information you provide contains personal data this information will be used solely for historical research and archiving purposes and may be published on the Thamesmead Community Archive which will be available online.

Our legal basis for processing the information you give us

We process the information you give us under the General Data Protection Regulation ("GDPR") on the basis of "legitimate interests". We consider that we have a legitimate interest in documenting the development of Thamesmead for historical/research/archiving purposes and that there is a wider social interest in publishing that information for the same purposes.

Your Privacy Rights

Transparency: You have the right to be informed about how we are using your data. If you think we are doing something with your information that we have not told you about in this Privacy Notice, you can object to this.
